Have you enrolled with ePREP?



Maryland Medicaid requires all providers rendering care to Medicaid beneficiaries enroll with Medicaid's new electronic **P**rovider **R**evalidation and **E**nrollment **P**ortal (ePREP). Maryland's ePREP system is Medicaid's one stop shop for provider enrollment, re-enrollment, revalidation, information updates and demographic changes. According to the Maryland Department of Health, all providers submitting claims for HealthChoice members must enroll with ePREP *as soon as possible*. <u>Failure to properly enroll or remain in an active status with Maryland Medicaid's ePREP system may result in claim denials</u>.

VBPI 2019: We need your help!

On an annual basis, Maryland Medicaid selects specific HEDIS® and encounter based quality indicators for its *Value Based Purchasing Initiative (VBPI)*. VBPI is one of the methods used by the HealthChoice program to gauge the performance of participating Managed Care Organizations. Currently, there are only about three months left in the year and we have a lot of work to do in terms of making sure we meet our targets for the CY 2019 VBPI. The measures in the chart to the right are of critical importance to our organization. Please continue to work to bring into care our members, your patients, who may be failing one or more of these quality measures.

Alert: HIV/AIDS Medications Carve-In

Beginning January 1, 2020, HIV/AIDS medications will no longer be covered under the Maryland Fee for Service program. Instead, these important medications will be covered by Jai Medical Systems' pharmacy benefit. For the first six months of this transition, there will be a smoothing period for members who have already been prescribed HIV/AIDS medications. We recommend that providers who are prescribing HIV/AIDS medications, including Truvada, check our website for updates regarding our formulary options as well as any criteria such prior authorization for individuals receiving these medications.

Diabetes Prevention Program

Effective September 1, 2019, Jai Medical Systems is offering a Diabetes Prevention Program to provide you with support and tools for your members to lose weight and reduce their risk of getting diabetes. This program is offered at NO COST to our members. Hepatitis C Treatment Update

Maryland Medicaid has updated the prior authorization (PA) criteria for the treatment of Hepatitis C, effective July 1, 2019. The most significant change to the criteria is that the minimum qualifying fibrosis score for treatment is now F1 (previously it was F2). Also, members under age 21 do not have to meet the fibrosis score threshold in order to be approved for treatment, though a fibrosis score is still needed in order to determine the correct treatment and duration. Beginning, January 1, 2020, Maryland Medicaid will modify its criteria standards to include a minimum qualifying fibrosis score of F0 or higher for treatment.

Jai Medical Systems will continue to use the clinical criteria from Maryland Medicaid when approving all treatments, but patients must be ineligible for a preferred treatment before a non-preferred treatment will be approved. The current list of preferred treatments for Hepatitis C remains:

Generic Harvoni (ledipasvir-sofosbuvir)Genotypes 1,4,5,6Generic Epclusa (sofosbuvir-velpatasvir)All GenotypesZepatierGenotypes 1 and 4MavyretAll Genotypes
